 - 2. Public Comment Documentation Submission: Any individual or group who wishes to present documentation during public comments must be listed on the meeting agenda. To be included on the agenda, the individual must submit their documentation in accordance with this policy, ensuring that it is provided to the trustees no later than 48 hours in advance of the meeting.
 - 3. Compliance:
 - Documentation that is not submitted within the 48-hour window will not be considered during the meeting. This policy ensures transparency, fairness, and the ability for trustees to give full consideration to all materials provided.

By adhering to this policy, we endeavor to enhance the efficiency and fairness of our board meetings, ensuring that all trustees and members of the public have sufficient time to review and consider the necessary information.

- i. Policy Clarification on Attorney Communication
 - Board Reiteration: All communications between the Town Attorney and the Town Clerk / Administrative Director must include the Mayor as a recipient (cc'd), with the exception of CORA (Colorado Open Records Act) requests. If the communication pertains directly to the Mayor, the Mayor Pro Tem must be copied instead of the mayor to ensure proper oversight and transparency in the process. This policy is intended to maintain clarity, accountability, and effective communication within the board while respecting confidentiality where necessary.
