1. Motion Sense Review

Amanda Pierce presented the bill from Oliver Construction for Motion Sense that has consistently had issues with wipes clogging their service lines. Grover Price, Motion Sense Owner, is now asking for the Norwood Sanitation District to pay for it as it is sludge this time. He has a low flow toilet, so it does not have enough water flow to push through the service line. It has been suggested that he get a washer or toilet with more water flow. The lease he has states that his service line is his responsibility.

The NSD Board discussed the Town of Norwood meeting. Kerry Welch feels that it was absolutely not ok to research dissolving a sanitation district without our knowledge and consent. Brad Campbell further states that it was inappropriate to spend money on legal services regarding dissolving the Norwood Sanitation District. The NSD Board discussed the Town of Norwood agenda changing three times, making 4 agendas, including the original. Brad would like to know what the motive was. Mike Grafmyer introduced what a non-confidence resolution was and asked for it to be put on next month's agenda.

Public Comment:

Ray Cossey states that he has concerns about the resolution and would like to know what it is for.

Mike Grafmyer made a **motion** to move agenda item 3 to 4 and agenda item 4 to 3. Kerry Welch seconded the **motion**. All voted **yes**. *Motion passed*.

Bernice White asked what the goal was for the resolution. Mike Grafmyer states that they will present it to the Town of Norwood Board.

Bernice White wanted to know if the Norwood Sanitation District had talked with Mayor Candy Meehan or the Town of Norwood. Mike Grafmyer states that they went to the Town of Norwood board meeting.

Ray Cossey feels there should be a joint meeting between all three boards. Tom Kyle states that this is a very serious situation and that it was too late.

Mike Grafmyer explained that we have received a copy of the new IGA and what has happened with the incurred legal fees and its relevance to the Norwood Sanitation District without any prior knowledge of the NSD Board, which included a dissolution to dissolve this special district. He also states that a meeting between all three entities is what should have occurred before any of this occurred.

Jenny Russell feels that Mayor Candy Meehan had legitimate questions and does not think she discussed dissolving the district. Mike Grafmyer states that it was even on the bill. Jenny questioned the Norwood Sanitation District's legitimacy, and she does not feel it is a separate entity from the Town of Norwood. Keifer Parrino feels the NSD reports to the Town of Norwood as well.

Valerie Gibson feels this is all about truth and trust. She also feels everyone should be under one entity.

Alex Pape read a statement. He feels that everything going on right now shows disfunction and hostility. He does not feel it is all Mayor Candy Meehan. He feels the administration should be commended.

Tom Kyle asked about client/attorney privilege.

Shawn Fallow states that the Town of Norwood Board gave Mayor Candy Meehan permission to look into the Intergovernmental Agreement which is how dissolving the Norwood Sanitation District came about and he states that we need to have goals.

Chance Reed states that you have to know what your responsibilities are.

Mike Grafmyer asked why no one was worried about all of this now after all these years.

Mayor Candy Meehan explained why she asked the questions regarding the Norwood Sanitation District and the Norwood Water Commission. She feels that when she worked on the grant that it was the start of helping and that she has no intention of dissolving the district.

Tom Kyle asked Mayor Candy Meehan about how Deana Sheriff was treated and asked if she has tried any conflict resolution. Tom is concerned about the mayor's credibility.

Mayor Candy Meehan feels it is the Town of Norwood's fiscal responsibility to cover the Norwood Sanitation District if something ever happens. She feels the staff has not had proper training as far as legal silos. She wants to find the caveats and build from there. She still doesn't have clarity. Brad Campbell thanked her for her statement. She states this was not a coup on the Sanitation District.

Keifer Parrino states that he thinks the Norwood Sanitation District reports to the Town of Norwood. Mike Grafmyer states that we actually report to the Secretary of State.

Jenny Russell asked for the documents to be provided showing the district is legitimate and she will be making a CORA request.

Mayor Candy Meehan will still do things for this community. She states she is sorry the Norwood Sanitation District felt attacked. She states she is incredibly responsible for not knowing how much the attorney cost.

Kris Holstrum feels the verbiage of the resolution is inappropriate.

Bernice White feels the resolution is wrong.
